**PROGRAM:** Beyond Venus and Mars: The Journey of Understanding the Psychology of Sex and Gender

SPEAKER: Dr. Susan Burns, President, College of Mount St. Vincent




As a research psychologist, former faculty member, and now President of the College of Mount Saint Vincent, Dr. Susan Burns has spent years learning about and teaching on topics of sex and gender. In her talk, she will highlight some interesting historical approaches to understanding gender differences and recent research insights on the similarities and differences of women and men. She will also briefly discuss her gendered experiences that led her to writing a textbook, *Psychology of Sex and Gender*, released in 2019.

Dr. Burns is widely published, authoring numerous articles and research papers for peer-reviewed journals. She has co-authored a textbook titled *Human Relations for the Educator: Meeting the Challenges of Today and Tomorrow*, now in a second edition, and she most recently authored a textbook titled *Psychology of Sex and Gender*, a text designed for courses in gender, gender issues, the psychology of women or men, and sex roles, as well as sociology and anthropology courses on diversity. She earned her bachelor's and master's degrees in experimental psychology from Emporia State University and her Ph.D. in social/personality psychology from Kansas State University.

# RECORDS OF THE MOUNT KISCO AREA BRANCH IN THE LATE 1950'S Submitted by Elaine Weiss, Branch Historian

AAUW Westchester Vol.1, No.1 began with the work of Co-Editors Betty Bayley and Marie Richardson distributed the October -November 1957 for the Mount Kisco Area Branch. The bi-monthly or monthly News of our Branch begins here.

Betty Potter was the first woman mayor of a Westchester town or city. Mayor Potter was the guest of honor at the October 2nd. meeting. She spoke informally about her activity in local government and shared insights into the work of a mayor of a growing village. At the November 6th meeting Mrs. Selma Brody, Supervisor of Senior Citizens Activities of the Westchester County Recreation Committee, was the speaker.

The first study groups were started. They were Great Books, Mental Health, and Social Problems and Welfare.

The National Convention of 1957 took place in Boston. Committee reports were summarized.

The National Committee of the AAUW followed suggestions from branches and established the following list of committees: the Arts, Elementary and Secondary Education, Fellowship Program, Mass Media, Membership, Program, Social and Economic Issues, and the Status of Women.

The 1958 October-November newsletter promoted the Theater Study Group. Members were asked to see a play and discuss it in a way that would inspire others to look forward to the experience.

The study groups passed a resolution that would encourage new members to join the study groups. This resolution included the following, "Women not eligible" to AAUW membership may attend study group meetings for a fee of 50 cents per meeting."

#### **HONORING WOMEN IN PUBLIC SERVICE**

March was Women's History Month and many women were honored for their past excellent achievements and their dedication to achieve equal opportunity and equal pay for women. However, AAUW also stresses the importance of recognizing women who are outstanding achievers today. Since 1973 The Fund for the City of New York and the Alfred P. Sloan Foundation have honored extraordinary NY City Public Servants through its Sloan Public Service Awards which are widely regarded as the Nobel Prizes of City Government. The Fund states "This program annually honors six outstanding civil servants whose work performance and commitment to the public transcend not merely the ordinary but the extraordinary – day after day and year after year." For 2021 the six awardees included the three following women.



Lynette Parker is employed as a Supervising Attorney in the NYC Department of Housing, Preservation & Development where she carries a large portfolio of cases. All Manhattan based cases in the Housing Litigation Division are under her supervision. She also oversees all NY City "7A administrator" cases. These cases often have the worst housing conditions. She began her career as an attorney at the Administration for Children's Services. In 2002 she was recruited to HPD. The award statement said that Ms. Parker was chosen because "she is dedicated to ensuring all New Yorkers have safe and decent housing and has been effective in pursuit of this goal."

Paula Evans for the past five years has held the position of Director of the Admitting Department at Metropolitan Hospital. The hospital provides services for Harlem, East Harlem and Yorkville. Her first career was as a military and then civilian nurse in Guyana. In the United States she completed a nursing program and in 1992 began working in the NICU at Metropolitan Hospital. She quickly became Manager of the NICU and has also served in many other key roles at the hospital. The award stated she was chosen because "her dedication and creativity contribute to the success of the hospital helping countless patients."

Tara Boirard is the Senior Deputy Director for Housing and Economic Development, Value Engineering, Infrastructure and Community Development at the Office of Management and Budget (OMB). She oversees and coordinates all aspects of budgeting and financial management for every NYC agency related to housing and economic development. The award states that "OMB manages the City's \$102.8 billion budget and oversees the budgets of more than 90 city agencies, evaluates the efficiency and cost effectiveness of city services and proposals, and helps implement the borrowing and bond programs that support the \$17 billion capital budget."

Eligibility and nomination for the awards includes, in part, the following traits: Extraordinary service with ingenuity and compassion; Responsiveness to public needs and better service delivery; Outstanding and reliable performance under pressure and in times of crisis; Willingness to take risks when needed to improve services or correct abuses or inequities; Ability to adapt to change and provide a continued high standard of service delivery: Dedication to upholding public interest in the midst of competing interests, pressures and demands.

The three women chosen for the 2021 Sloan Public Service Award embody these traits and are even more remarkable because they were able to continue to utilize the traits to successfully carry out their responsibilities despite the crisis of COVID19 and the ensuing financial deficits of New York City. They also demonstrate that women given the opportunity to move up the career ladder can be extraordinary, responsive, knowledgeable, successful and compassionate.

In April the Membership will vote on the 2022-2023 Budget, and the incoming Board of Directors and the acceptance of the dues change for 2022-2023.

AAUW National is again raising our yearly dues by five dollars, bringing the total National dues to \$67. NY State dues will be \$7 this year. As a result, we have had to raise your total membership dues by five dollars to \$103.

Attached is the budget for 2022-2023. Our calendar year runs from July 1, 2022 through June 30, 2023. When you review the budget, you will notice that we are projected to operate at a deficit, as we have done for the few past years. In order to minimize this deficit, the Board voted to include an option to allow our members to make an additional donation when they are renewing their annual membership. We hope that you will consider adding a donation to your dues. The dues renewal form will include the option of making an additional donation to support the 8th grade Educational awards. Sr. H.S. educational awards, and/or the branch's operating funds.

The membership must vote to accept any increase of dues, so this is on the ballot along with the budget and the slate of officers.

### ADVOCACY ACTIVITIES – MARCH-APRIL 2022 by Jane Pendergast

Equal Pay Day – March 15 – this year will have featured rallies in New York City, Rochester and other cities, with the NYC rally at 1 pm also welcoming digital attendees. Importantly, this year's events have also included a legislative briefing with the sponsors of the salary range transparency bill. POWHER New York has worked to gain passage of



this bill in the NYS legislature that will require employers to provide the salary range of job openings in all job announcements – a simple way to address the elusive goal of equal for women and all prospective employees. We have received indications that the bill has a good chance of passing this year. A similar New York City law passed early in the year.

POWHER New York continues to advocate actively for important issues affecting women on the state level, including a 2/15 briefing on the governor's budget, detailing the budget for key areas: childcare and fair pay for home care. Advocates for home care fair pay will continue to press for increased funding, but Federal funding is likely to be limited in the current environment. The briefing also included updates on legislative priority issues, reproductive health access, pay equity, comprehensive sexuality education, and the equality amendment.
